

**Survey Design**

## ***Introduction***

During the 1990s, 24 UNECE countries progressively joined the FFS project. National representatives were responsible for the survey sampling and for launching the fieldwork in their country. As of 1992, a standard FFS Questionnaire was available. Countries complied in different degrees to this standard questionnaire in their national instruments. Some standard information on the survey design is available for all countries. Some countries prepared more elaborated national reports on methodological issues.

## ***Participating Countries***

The United Nations Economic Commission for Europe comprised in the 1990's 54 countries.

Since the late 1980's UNECE countries progressively joined the FFS project. By the end of the project 24 countries participated in the project.

The table below gives an overview of the 24 countries that participated in the FFS project. Moreover, it spells out some characteristics of the samples and the timing of the national fieldwork.

## ***Sampling***

Details on the sampling procedure, the data collection, the non-response, the weighting and post-stratification are given for each country in the Technical Annex of the Standard Country Report.

A critical evaluation of the sampling can be found in the FFS Evaluation Report written by P. Festy and F. Prioux.

## ***FFS Model Questionnaire***

During the late 1980s and early 1990s, an FFS model questionnaire was developed. In the course of 1989-90 the Center for Population and Family Studies (CBGS) in Brussels prepared and tested several drafts of an FFS model questionnaire. This model was discussed and amended during the course of various meetings with members of the FFS Informal Working Group in 1990-1991. The outcome of this process was a minimal core questionnaire and optional modules.

The Institute for Research Development, Columbia, Maryland (USA) pre-tested the FFS core and module questionnaires in January 1992. More information on this pre-test can be read in the FFS Newsletter 2.

The final model questionnaire contains 9 Core sections and 4 Optional Modules:

- Section 0: Household Characteristics
- Section 1: Parental Home
- Section 2: Partnerships
- Section 3: Children
- Section 4: Other pregnancies
- Section 5: Fertility regulation
- Section 6: Views on having children
- Section 7: Other views
- Section 8: Education and occupation
- Section 9: Partner characteristics
  
- Module 1: Migration History
- Module 2: Contraception History

- Module 3: Values and Beliefs
- Module 4: Population Policy Acceptance

Two versions of the FFS model questionnaire have been developed: one for men and one for women. The two questionnaires differ mostly with respect to questions on abortion and contraception. The questionnaire for women has been included for access here.

The model questionnaires were designed with the Integrated System for Survey Analysis (ISSA), the software first used in the Demographic and Health Surveys (DHS) project of Macro International, Inc.

Full version of the Questionnaire and its Codebook is available as well as FFS Standard Recode Files and Standard Country Reports.

In the FFS project, this ISSA software has also been used for data entry and for generating the standard tables to be included in each FFS Standard Country Report.

The Institute for Resource Development (IRD), Columbia, Maryland (USA) has provided training in the use of ISSA at an FFS workshop, which took place in February 1992 in Warsaw (Poland). More information on this training can be read in the FFS Newsletter 2.

## **FFS National Questionnaires**

In actual practice, few countries stick to the exact FFS model questionnaire. For instance, when designing their national FFS questionnaires, some countries have:

- deleted one or more model questions;
- phrased one or more model questions differently;
- added one or more questions that are not part of the FFS model questionnaire;
- followed different skip patterns for one or more model questions;
- used different coding scheme for one or more model questions.

Moreover, several countries had to and/or wanted to take into account national traditions and national priorities.

Hence, the national FFS questionnaires quite differ from each other. There are important differences between the participating countries in the degree to which they have complied with this model questionnaire. More information on the links between the model questionnaire and the national questionnaires can be found in Comparative Research.

If available, the national questionnaire in the **original language** and the translation of the national questionnaire into **English** are included in the table of country specific documents.
